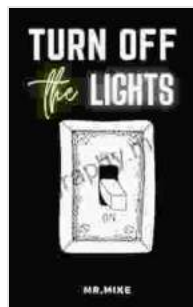


Turn Off the Lights: The Extraordinary Case of Michael Rotondo and the 838 Violations

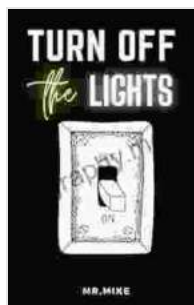
